

Amenity and Recreation in the Maigue Rivers

Maigue River catchment area as part of a LEADER funded project. On behalf of the Trust, **Deirdre Lewis SLR** Consultancy has been mapping the current recreational and amenity provision (Walking, Cycling, Angling, Boating, Nature Viewing and Heritage Amenity) and engaging with various players to identify gaps and opportunities.

River Insects

On the 5th June, the Maigue Rivers Trust was delighted host Dr Mary Kelly-Quinn, lecturer and freshwater research scientist from UCD to train-the-trainers on how to teach freshwater biomonitoring (using river insects) to citizen scientists. Our training venue was provided by Scoil Pól Principal, **Mike O'Hara**, who very kindly gave us permission to use their science laboratories and Agriculture Science teacher, **Claire Birmingham**, was part of our group of trainers. We spent the morning looking down microscopes getting familiar identifying species by their appearance, and in the afternoon we were out in a local stream of the Loobagh practicing our sampling and identification skills. We are happy to report the water quality was of good ecological status.

2021 EU Water Blitz & Earthwatch Europe

MRT took part in EU Waterblitz 7-10th May in conjunction with



DCU Water Institute using water testing kits fund by the EPA and Mary Immaculate College. Some 400 samples were taken across the country including 12 samples from the rivers of the Maigue which measured nitrates and phosphate levels. Maigue citizen scientists were **Conor Kirby, Mikey Foley, Rhiannon Laubach, Nicole Dennehy and Morgan Murphy**.

Educational Leaflet on the Maigue

The MRT have published a new educational factsheet entitled **'Understanding the Maigue Rivers'**. The factsheet is for 2nd level students and communities of the Maigue catchment and focuses on riverine processes and controls as well has human modifications and their consequences.

Giant Hogweed is regarded as one of the world's worst invasive alien plants and is increasingly becoming a major issue across the Maigue catchment. Alarmingly, it is now increasingly found at field boundaries, along road verges and in people's gardens. The weed has a damaging effect on the native habitat, and reduces value of land and can hinder anglers from river. The MRT advise all communities of the catchment to be alert to this increasing threat and will continue to campaign for national government and local councils to devise and implement methods that control the dispersal of Giant Hogweed.

Recently, the Trust won a contract to devise a management strategy for Giant hogweed on the Morningstar. Work has commenced in August 2021 and the report is due in Nov 2021.

Crayfish Plague Update

The Crayfish plague eDNA results were received from the Marine Institute in February. Unfortunately all sites tested are positive for the presence of the crayfish plague. The Loobagh at Garoose Bridge, Bruree, Athlaca – Morningstar, Manister – Camoge, Croom, Castleroberts and Adare. As of June 2021 Crayfish plague is now confirmed in the Loobagh at Kilmallock. Crayfish Arc

The Trust are examining the potential of establishing "Ark" sites for White-clawed crayfish to conserve this threatened invertebrate. An Ark is an isolated refuge site where new plague-free populations are established, safe from threats. An application to LEADER to undertake a feasibility was successful and work to identify suitable sites is currently underway. Niamh Sweeney of Aktins Global has been commissioned to carry out the feasibility study.

MRT Strategic Plan

The MRT are in the process of developing a Strategic Business Plan. The strategic plan will articulate the goals and objectives of the Trust, and the essential steps and actions need to be taken to accomplish those goals. Ballyhoura Development Company appointed Tom O'Leary of 'Result' to be the MRT business plan mentor.

'Reimagining Irish Rivers' Online Conference



The Maigue Rivers Trust co-hosted a hugely successful online conference on Reimagining Irish Rivers on March 22nd and 23rd. The speakers were from community, agency and environmental organisations and inspired audience members with their descriptions of functioning unimpacted rivers and their efforts go the extra mile for nature-based solutions for degraded rivers.
